Installation of two new sewage pump stations and appurtenances including electrical, controls, emergency generator, site work, approximately 6,300 LF of 8-inch forcemain and 175 LF of 10/12-inch gravity sewer installed by horizontal directional drill and open cut methods, maintenance of traffic and other miscellaneous/ancillary related work as indicated within the contract documents. Work includes furnishing all equipment, material, and labor for the work described in the contract document drawings and specifications.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis.
